5. Finance Annual Report

Phil Brown reported that 2021 had been a very good year mainly due to the income of £1050 from Bolton Ironman (£50 of which was earned extra by Allan Ricketts for handing out leaflets to residents affected by road closures). There were also 7 new members. With this finance available, the steering group agreed to use £489.60 towards first aid training for 12 members. The balance at the end of 2021 was £859.88

There was a thank you to Phil Brown for all his efforts with the accounts and to Phil Bradley for auditing the account.

6. Constitutional Proposals

It was agreed and seconded that the membership fee should continue to be £10 and the financial year of the club will run from 8th December, in line with the end of year AGM meeting.
